#### INTRODUCTION

The Ganmo division is known as an arresting institution which is located at Ganmo Ilorin, Kwara State. This division is a special one to the area of Ganmo which is located at Ilorin

The establishment of the station is to provide adequate community policing to the people of Ilorin local government. Since the existence of the station several police officers has retired, transferred and promoted by the police service commission who are in charge to promote, dismiss and discipline officers in the police force. The name of the divisional police officer (DPO) is DSP Salamat Halivu who is a native of Kaduna Northern Nigeria.

# OFFENCES COMMITTED AND THEIR SECTION OF PUNISHMENT ACCORDING TO THE CRIMINAL CODE:

**ASSAULT:** If charged to court shall be liable for 1 year imprisonment, according to section 351 of the criminal code 1990

**ASSAULT OCCASSIONING HARM:** If charged to court shall be liable for 3 years imprisonment, according to section 355 of the criminal code

**STEALING:** If stolen goods worth more than 1000 naira and upward shall be liable for 3 years imprisonment. If stolen cycle or car shall be liable for 5 years imprisonment or maximum of 7 years imprisonment, according to section 390(9) of the criminal code 1990

**OBT, (OBTAINING MONEY UNDER FALSE PRETENCE):** If charged to court shall be liable for 5years imprisonment, according to section 419 of the criminal code 1990

**BREAKING AND ENTERING:** if charged to court shall be liable for 14 years imprisonment, according to section 411 of the criminal code 1990.

# DOCUMENTS THAT CAN BE FOUND AT GANMO DIVISION ILORIN KWARA STATE

At Ganmo Division, Ilorin Kwara State, some diary can be found at the counter.

These diaries are:

- **Crime Diary**: The person who is in charge of this diary is known as CRO (charge room officer)
- **Routine Diary**: the person who is in charge of this is known as Writer 1
- PPLR (Prisoner's property lockup Register): The person who is in charge of this register is known Writer 2

- **Detention Board:** It comprises of the name of the suspect, sex, date, offence committed, IPO in charge and remark
- Staff Notice Board: This board is used to pass information to officers on duty

# INSTRUCTIONS TO SIWES STUDENT AT GANMO DIVISION, ILORIN STATE

- Every attachment letter must be signed duly by the commissioner of police at challenge Ilorin, Kwara State before the posting to any divisional/special jurisdiction for internship.
- The student must be trained both theoretical and practical knowledge of the field
- The student must have a special supervisor in any section he/she is being posted to Ganmo.
- Indecent dressing is not allowed

# STUDENT'S OBSERVATION OF SAFETY RULES AND REGULATIONS AT GANMO POLICE STATION ILORIN KWARA STATE

- Always present a valid form of identification when entering the police station.
- Conduct yourself respectfully in the presence of officers and staff. Avoid disruptive behavior, loud noises, or inappropriate language.
- The division is responsible in charging cases to court
- Any food being brought must be tasted by the person who brought the food before being given to the suspect
- No suspect is allowed to be detained with phones, money, belt, cloth, shoes or any object. Those items will be registered by the writer 2 in charge of the prisoner's property lockup register (PPLR) at the counter.
- Every day, the list of all suspects is taken using the "cell state" and it will be signed by the DPO.

- 7. Statement of the suspect
- 8. Medical Paper
- 9. Bond to Produce Exhibit

- Introduction of the case
- Statement of the Complainant
- Statement of the Suspect
- DPO'S Interview
- Detention order

The diagram below will help to understand the documents that are attached to be qualified as Particulation of actions.

### PARTICIPATION OF ACTIONS

The Index has to do with the list of document to be attached to the case file. For example;

- Extract from crime diary will be written as A1
- Police Investigation Report will be written as A2
- Minute Sheet will be written as A3

- Statement of the Complainant will be written as A4
- Statement of the Suspect will be written as B1
- Medical paper will be written as C1

#### **INDEX**

In the Extract from crime diary, we have the

- Date
- Serial number
- Time
- Cross reference
- Details of Entry

In the police investigation report, we have the;

- Introduction
- Investigation
- Facts
- Findings
- Opinion/ Suggestion

The Minute sheet is written to the IC of the department. The meaning of IC is Inspector crime whose name is Inspector abbey of DCB ONE Department. It is written to the IC for him to be aware of the case about to be charged to court and it must be brief with points.

The Statement of the Complainant must be recorded freely using plain Statement sheet

The Statement of the Suspect must be recorded voluntarily under caution using caution sheet

The medical paper is given to the victims who sustain injury to be taken to the general hospital and it is attached to the case file. Note that the medical paper is given to

victim who engaged in a domestic violence, assault occasioning harm, Child abuse, Rape, Defilement and Accident

#### SUMMARY OF INDUSTRIAL EXPERIENCES ON THE SIWES LOG BOOK

My Internship training was done at Ganmo Division located at Ganmo Area Ilorin Kwara State. On 2nd of August 2024 I went to police headquarters located at challenge Ilorin Kwara state

For the approval letter from the Commissioner of police of the state whose name i his CP Olaiya Victor Mobolaji On the 5th of August 2023, I started my internship at Ganmo Police Station in which i was introduced to all the offices by ASP Titilope Idris After the introduction, I was assigned to DCB ONE, (Divisional Crime Branch) department for my training and was referred to Inspector who is my supervisor during my internship. Here at Ganmo all suspects are brought out every morning to be searched and returned back to the cell.

During my internship training, I witnessed all cases of crime reported at the counter in which those cases were assigned to my department for further investigation. Such cases are breaking and entering, burglary and stealing, obtaining money under false Pretense, Affray Assault, Assault occasioning harm, domestic violence, stealing, conduct likely etc. I was trained on how to charge suspects to court with the use of case file. Note that, suspects are charged to court on Monday, Tuesday and Thursday.

On the 5th of Aug 2024, I witnessed a case of house breaking and theft by Mr. Sodiq Ahmed The case was reported at the police station and assigned to DCB one for investigation in which the suspect was later granted a bail. On the 13th of Aug 2024, a case of attempt stealing was reported at the station by one Alitade ashier who parked his car in his compound Toyota camera NO FST 849, BC LAGOS and an unknown their broke in to remove his car battery The case was assigned to DCB one for further investigation On the 14th of Aug 2024 a case of destroyed property was reported by one Lekan Afolabi who brought a goat that destroyed his Maize and potato farm at about 16:30hrs and assigned to DCB one in which the goat was been detained and the

owner was asked to report to the station. On the 15th of August 2024, a case of decent assault was reported to DCB one by one Miss Halimat against his boyfriend And he was later Detained for further investigation. On the 16th of August 2024, a case of breach of trust was reported against one Abudullhai Abudulsalam a plumber who was given a work but never deliver or return the plumbing machine it was assigned to DCB one and the suspect was arrested but granted bail after a written undertaking On 19th of Aug 2024, a case of house breaking and theft was assigned to me which I recorded the statement of the complaint freely using a plain statement sheet which we went ahead to check the scene of crime and investigation was being carried on. On 20th of Aug a case of sudden and natural death was by a hotelier PA to chairman Mornarch Hotel Ilorin, Kwara State which all the workers were arrested and later freed on bail after investigation in which they were not guilty which afterward i was lectured difference between man slaughter and natural death.

On 27th of Aug 2024, a case of shop breaking and theft was assigned to me which I was went to the scene of crime for further investigation with Constable blessing. On 1st of Sep 2024 a case of assault and conspiracy was reported to DCB and the suspect was been locked up in cell. On 15th of Sep 2024 a case of a missing person was reported to DCB by one Mayeloye who was an Arabic teacher and I was assigned to taken down the complaint statement when further investigation was been carried on. On 19th of Sep 2024 a case of public disturbances was reported by one Toyin Rasidat against her fellow market women Sarat who the two of them was detained after investigation. On 20th of Sep 2024, I recorded the statement of a complainant using plain sheet which was recorded freely. On 21st of Sep 2024, I recorded the statement of a suspect using caution sheet which was recorded voluntarily. On the 22th of Sep 2024 a case of missing wallet was assigned to me and I take down the statement of the complaint.

On 23rd of Sep 2024, I was lectured on how to make arrest using warrant by my supervisor. On 24th of Sep 2024, my amicable internship supervisor whose name is Mr. Ajibade. On 30th of Sep 2024 a case of domestic violence was report to the DCB by one Ayofe Esther against her husband which she sustained seriously injury's and a

miscarriage the husband flew from the house but the family of the husband was being summoned to bring their son to the station to avoid the parents being detained I was assigned to take down the complaint statement. On 1st of Oct 2024, a case of house breaking and theft was reported to the DCB about an unknown thieves or thief who broken in through the kitchen burglary and destroyed the pop ceiling and got away with some expensive items worth the value of four hundred and eight two thousand all together.

On 2nd of Oct 2024, the DPO whose name is CSP Salamat Halivu gave me the opportunity to visit the cell. The reason I visited the cell was to interview the suspects and give them a word of encouragement. Note that, before then, I visited the cell constantly where i requested the constable on duty to bring my suspect out for interrogation and then returned back to the cell. On 6th of Oct 2024 a case of stolen motorcycle was reported to the DCB by one Iyanuoluwa who parked his motorcycle TVS black color worth three hundred and sixty five thousand naira inside his compound only to get missing the following morning.

On 7th of Oct 2024, I concluded the list of suspects using the cell state. On 8th of Sep 2024, a case of breach of trust was reported by one Mary Ayoride against Ayobami Rita which I recorded the statement of the complaint voluntarily and the suspect under caution and the case was charged to court by the IPO in person of inspector Titilope Idris and I. And was also in court to witness the sentence which she was later granted on bail and a date to pay off her debt

### **CONCLUSION**

As a SIWES student, compiling of case file, granting of bail, investigating cases and arresting of suspects are my practical aspect of the internship in which i can put them in work after graduation. The theoretical aspect such as having knowledge about the activities of the agency is part of my achievement as a SIWES student.
