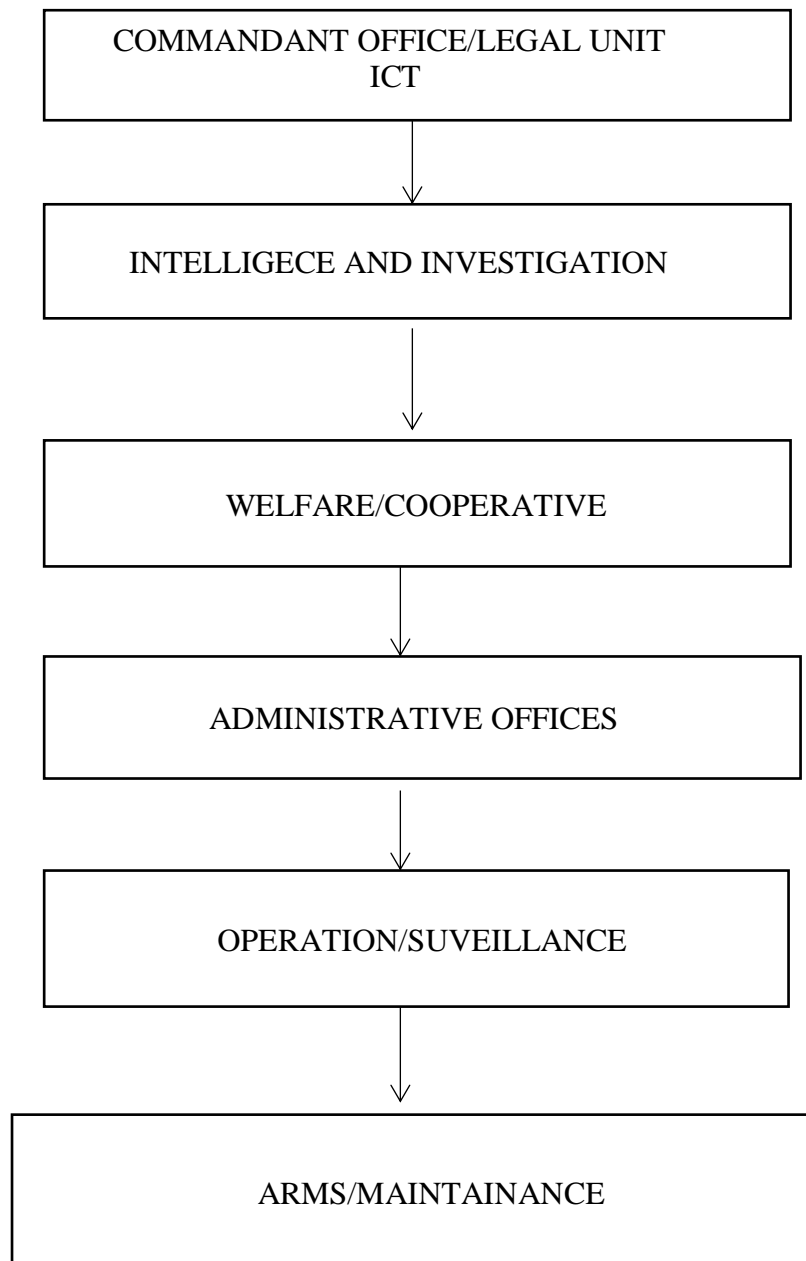
INTRODUCTION
